In order to further develop cooperation in the fight against the hostile activities of special services and foreign centers of ideological sabotage of the enemy, the 10th Directorate of the KNB of the Czechoslovak Socialist Republic and the 5th Directorate of the KGB of the USSR, based on the decisions of the 17th Congress of the Communist Party of Czechoslovakia and the 20th Congress of the CPSU - as well as the Protocol on the results of negotiations between the delegations of the Federal Ministry of Internal Affairs of the Czechoslovak Socialist Republic and the State Security Committee of the USSR of November 14, 1984, agreed to cooperate in 1987-1991 in the following

to combat the activities of foreign centers of ideological  
sabotage of the enemy

I. Continue coordination and interaction in the development of foreign ideological, nationalist, Zionist, reactionary clerical and émigré centers, pacifist, extremist and other anti-communist enemy organizations,

carrying out acts of ideological sabotage against the countries of the socialist commonwealth.

During their development, pay special attention to:

- obtaining information about signs of possible enemy preparations for a surprise nuclear missile attack on the socialist camp;
- identifying, suppressing and documenting plans, specific preparations and hostile actions of enemy ideological sabotage centers aimed at undermining and weakening the military-economic potential and socio-political system of our countries;
- uncovering and suppressing the intelligence and emissary activities of these centers and organizations;
- identifying and suppressing the enemy's attempts to create a deeply conspiratorial underground organization on the territory of our countries.

2. Both sides are to prepare lists of priority operational interests for specific enemy ideological sabotage centers being developed. Determine the circle of agents and trusted persons who have or may have the ability to develop these centers, and instruct them to obtain information on the items on these lists. Timely exchange the information received for the purpose of developing and conducting further joint intelligence and operational activities.

3. Based on the analysis of the obtained materials on the enemy's subversive activities and the accumulated work experience, prepare joint measures for agent penetration into leading foreign centers of ideological sabotage.

4. Intensify work on acquiring sources of information from among foreigners visiting our countries, regarding whom there is information about their connections with foreign subversive centers and organizations. Exchange the information obtained on such persons in order to organize their joint development.

5. Use all capabilities available to both sides to create conditions for our success in gaining access to the information retrieval systems of the enemy's foreign centers of ideological sabotage in order to obtain and quickly use the information entered into them to our advantage.

6. Conduct joint intelligence-operational and counter-propaganda activities aimed at preventing the coordination of the activities of various centers of ideological sabotage of the enemy and blocking them on a single anti-socialist platform.

7. Accumulate, analyze and promptly exchange information on the activities of the enemy's ideological sabotage centers, newly identified subversive organizations, their functionaries, emissaries and persons maintaining contact with them.

Through existing intelligence and other capabilities, to sow discord among the aforementioned individuals, to conduct joint activities to compromise and discredit them before the leadership of these centers, as well as before the world community.

8. Seek opportunities to obtain information about the activities of the Council on International Broadcasting (USA), which controls the political, financial and administrative activities of the radio corporation RS/RSE and is the main coordinating center of the enemy in the implementation of the plan for a new propaganda offensive against the Soviet Union and the countries of the socialist commonwealth.

To expose the connections of RS/RSE with other subversive centers and organizations, primarily with NTS, OUN, Svedetstv, Listy, etc.

Identify characterizing data on CIA employees, I work in those centers.

9. Closely monitor the efforts of the enemy, in particular the "Resistance International", to infiltrate the movement

supporters of peace with the aim of splitting it and discrediting the peace-loving foreign policy of socialist states. To expose and suppress attempts by foreign subversive centers, to establish contacts with like-minded people in our countries, to stimulate their hostile activity under the guise of so-called "independent movements for peace", "trust groups", etc.

10. To direct the agents of our countries to obtain information about attempts by enemy special services to use the peace movement in Western countries in their own interests.

Through agents of influence and other means, ensure that the leaders of these organizations refute the demagogic accusations of socialist countries of violating human rights, suppressing independent anti-war movements, etc.

To stop contacts between these organizations and hostile and anti-social elements in our countries.

To cooperate in the development of the pacifist organization "Ground Zero" (USA), which since 1983 has been implementing the so-called "Paired Cities Project", designed to inspire the so-called "independent pacifist movement" in socialist countries.

II. Cooperate in conducting intelligence and operational activities to obtain information about the enemy's use of the international PEN Club. Timely suppress attempts by this organization to penetrate the Czechoslovak Socialist Republic, the USSR and other socialist countries.

12. Prepare and implement joint intelligence and operational combinations with the aim of identifying, intercepting, and, if necessary, eliminating communication channels between foreign subversive centers and organizations and their agents and like-minded people in the Czechoslovak Socialist Republic and the USSR.

To provide these centers with proven agents of state security agencies.

When favorable situations arise, prepare conditions for conducting operational games with specific centers of ideological sabotage of the enemy.

13. Conduct joint intelligence and operational activities to identify and suppress the enemy's channels for transporting ideologically harmful printed materials, tape cassettes, video products and other equipment through the territory of Czechoslovakia and the Soviet Union.

14. Exchange experience in identifying and suppressing channels for transmitting slanderous information to the West by hostile elements, as well as sending them material and technical assistance from abroad in order to stimulate their antisocial activities.

15. By carrying out coordinated operational measures, expose and suppress the enemy's attempts aimed at legalizing and internationalizing the activities of antisocial elements in the Czechoslovak Socialist Republic, the USSR and other socialist countries.

To promptly apply comprehensive intelligence, operational and legislative measures that reveal his plans to create an anti-socialist underground on the territory of our countries.

16. Take the necessary measures to identify and suppress the enemy's intentions to combine anti-socialist activities with sabotage and terrorist actions.

To promptly uncover and localize the enemy's attempts to transfer this activity to the territory of socialist countries.

Immediately inform each other about the information obtained on this issue in order to develop joint countermeasures.

17. Pay close attention to newly discovered directions and forms of ideological sabotage by the enemy, in particular his use of pacifism, various religious and mystical teachings, antisocial manifestations among young people, the creation of so-called "independent movements for peace," etc.

Conduct a thorough investigation and deep analysis of the facts and causes of negative manifestations associated with such activities.

enemy, about which they must promptly inform each other. Prepare and implement joint measures that facilitate the forecasting, timely discovery, prevention and suppression of the enemy's plans to use non-traditional forms of hostile activity against the countries of the socialist commonwealth.

18. Develop joint measures aimed at the timely detection and suppression of attempts by special services and foreign ideological sabotage centers of the enemy to supply hostile elements with microelectronic computing equipment that makes it possible to encrypt, store and transmit to the West in coded form via telephone and radio channels intelligence and other information, decrypt messages received from abroad, reproduce ideologically harmful materials, conduct local television broadcasting by broadcasting texts and images of an inflammatory nature.

19. Develop and implement joint counter-propagandist measures that expose the reactionary essence of the enemy's central ideological dissent and reveal their connection with the special services of imperialist states.

20. Timely exchange of information obtained about the aspirations, characteristic features and changes in tactics, forms and methods of activity of the enemy's ideological sabotage centers being developed.

Twice a year, prepare and send each other general information on this topic.

1. Both sides will continue joint activities to identify, prevent and suppress the subversive aspirations of Zionist centers and organizations, infiltrate their functional management units, expose emissaries, intercept communication channels with hostile elements in the Czechoslovak Socialist Republic and the USSR, and create conditions for the initiation of operational games.

2. Joint measures in the fight against the subversive activities of the OUN should be subordinated to uncovering the plans and intentions of their leaders to carry out hostile actions against our countries, identifying the methods and tactics of their actions, emissaries and liaisons of national centers, interception and operational use for these purposes of illegal channels of communication of OUN members in the Czechoslovak Socialist Republic and the USSR.

Organize joint training of agents for long-term settlement abroad with the aim of infiltrating OUN centers.

In carrying out intelligence and operational activities, the main efforts are to be concentrated on preventing the enemy from creating an organized nationalist underground on the territory of our countries, identifying among nationalist elements persons involved in the subversive activities of foreign OUNs, organizing their joint development for the purpose of documenting and suppressing illegal activities, and preventing the leakage of slanderous and anti-Soviet information abroad. Take measures to disrupt the blocking of Ukrainian nationalists with other anti-socialist elements.

Through existing intelligence-operational and other capabilities, organize the continuous development of previously identified emissaries and liaisons of foreign OUN in the event of their visit to our countries.

Continue coordination and cooperation in counterintelligence support of the annual folklore festivals of Ukrainian songs and dances in the city of Svidnik (Czechoslovakia).

Counter-propaganda activities are to be subordinated to exposing to the world community the reactionary essence of Ukrainian bourgeois nationalism, the connections of the OUN with the special services of fascist Germany and NATO countries. Organize the exchange of counter-propaganda materials for their prompt publication in the press of the Czechoslovak Socialist Republic and the USSR and joint promotion in the Western mass media.

3. To direct intelligence and operational work against the NTS towards intelligence penetration into this subversive organization and its structural divisions, and to expose its emissary activities

the territory of the Czechoslovak Socialist Republic and the USSR, identifying illegal channels of communication with hostile individuals in our countries, as well as channels for the delivery of subversive literature, and conducting exposé and counter-propaganda activities.

4. In work on RL/RFE, the main efforts of both sides are to be concentrated on carrying out measures to infiltrate the said centers, identify and expose their personnel and agents, uncover, intercept and control RL/RFE communication channels with antisocial elements in Czechoslovakia and the Soviet Union, and obtain documentary information about the plans and intentions of the leaders of these centers and the directions of their subversive activities against our countries.

counteraction to the enemy's ideological sabotage

1. Continue cooperation in the adoption by both sides of counterintelligence measures to counter the attempts of special services and other reactionary forces of international imperialism to use the church and religion as an instrument of their political, anti-socialist intentions and goals for destabilizing the situation in the world and hostile penetration into the countries of the socialist commonwealth.

During the implementation of intelligence and operational activities, pay special attention to:

- identifying and suppressing enemy activities to compromise state church policy in socialist countries;
- identifying and suppressing enemy attempts to stimulate the activities of various illegal religious sects, orders and other underground groups on the territory of socialist countries;
- preventing the penetration of the Vatican into our countries, which, in accordance with its "Eastern policy," seeks to implement practical measures to politicize religion and strengthen its position among the Catholic clergy of the socialist commonwealth countries.

states, to revive the activities of illegal Catholic and Uniate communities in our countries; ..

- preventing attempts by enemy intelligence services to use subversive activities against the socialist camp, the so-called "Islamic factor";

- identifying and suppressing the enemy's intentions to influence broad sections of the population by introducing into socialist countries religious and mystical teachings fashionable in the West and creating on their territory various kinds of unregistered religious and philosophical seminars, schools, theological circles, etc.;

- implementation through intelligence-operational, administrative and legal capabilities of preventive influence on believers who allow politically harmful manifestations.

2. Through existing intelligence, operational and other capabilities, provide comprehensive support to church and religious circles that are active in the struggle for peace, against the danger of nuclear war, and that support the just struggle of peoples for freedom and independence.

3. Take coordinated measures aimed at identifying and suppressing attempts by the enemy to subversively penetrate the main international religious organizations, in particular, the World Council of Churches (WCC), the Conference of European Churches (CEC), the Christian Peace Conference (CPC), the Berlin Conference of Catholics of Europe (BCCE), etc. Through intelligence and other means, strengthen the positions of churches from socialist countries in these organizations.

4. By conducting coordinated intelligence and operational activities, exert a beneficial influence on the activities of these organizations. Through existing intelligence and operational and other opportunities, support progressively thinking employees, organize the development of individuals of mutual operational interest, identify their aspirations, connections, sources of financing, etc.

5. Continue coordination and cooperation in counterintelligence support for the further work of the Christian Peace Conference (CPC), which in modern conditions has exceptional political and strategic significance.

To use the existing intelligence and other capabilities to protect the KMK from the penetration of the hostile influence of Western representatives of churches and centers of ideological sabotage of the enemy, as well as to exert a favorable influence on progressive peace-loving, pacifist and loyal groups and individuals with the aim of attracting them in the future to the activities of the KMK.

Pay special attention to identifying the ideologically harmful influence on the KMK from Western pacifist organizations: the Inter-Church Council of Holland (ICH), the European Nuclear Disarmament (END), the Campaign for Nuclear Disarmament (CND), Pax Christi Internationalis (PCI), and Aktion Zünezeichen (FRG).

To achieve changes in the positions of these organizations on issues of so-called human rights and religious freedoms and in their relations with anti-socialist elements in socialist countries. To direct their efforts to an active struggle for peace and to support Soviet peace initiatives.

To create conditions for the promotion to leadership positions at the headquarters of the Christian Peace Committee in Prague and in regional committees of proven agents and trusted persons of friendly state security agencies, representatives of various Western organizations and groups capable of implementing the peace policy of the socialist countries. To disrupt the enemy's attempts to change the line outlined by the decisions of the VI All-Christian Peace Congress, which took place in Prague in July 1985.

6. To cooperate with the state security agencies of other socialist countries in conducting intelligence-operational and propaganda activities to further strengthen the authority of the Belin Conference of Catholics of Europe (BCCE) and to create conditions for the unification of left-wing Catholics on the basis of this organization in the struggle for peace and disarmament.

Take coordinated measures to protect the BKKE from attempts by reactionary forces to use it for their anti-socialist purposes.

7. Direct joint efforts to obtain documentary evidence that compromises the Vatican and its leaders before believers and in the eyes of the world community.

Use them more actively in operational practice and when conducting nationwide counter-propaganda activities. Focus on collecting information indicating the Vatican's connection with the NTS, international Zionism, the radio corporation RL/RFE and other subversive centers and organizations that have compromised themselves before the peace-loving public.

To obtain information about the subversive activities carried out against the Soviet Union, Czechoslovakia and other socialist countries by the "Secretariat for the Unification of Christians", "Secretariat of Unbelievers", "Secretariat for Religious Affairs of the Gregation" and Con-  
"Congregation of the Faith"., "Eastern

Prevent the Vatican's activity in inspiring the so-called "ecumenical movement" on the territory of our countries. By carrying out complex intelligence, operational, administrative and legal measures, expose and decisively suppress the Vatican's subversive penetration into the church environment.

8. Organize joint activities with leading international Protestant organizations, such as the World Council of Churches, the Conference of European Churches, the World Lutheran Union, the World Reformed Union, etc., with the aim of stimulating anti-Catholic sentiments among their leadership and preventing specific ecumenical cooperation with the Vatican.

9. Continue cooperation in the development of the foreign clerical-subversive center-sect "Jehovah's Witnesses".

To promptly exchange received data on the hostile activities of the sect, identified emissaries and couriers coming to the Soviet Union, Czechoslovakia and other socialist countries.

10. To cooperate in the development of the so-called "sectarian movement", represented in the Czechoslovak Socialist Republic by the sect "Decisive Christian Pentecostals", in the USSR by the sect "Pentecostals".

II. Use the existing intelligence and operational capabilities among the Greek Catholic clergy to uncover the plans and specific actions of the leaders of the foreign Uniates (Cardinal M. Lyubakhivsky, Bishop M. Rusnak) to intensify the activities of followers of the Uniate Church on the territory of the USSR.

12. Direct the efforts of both sides to collect information about the enemy's plans to use the church's celebrations of the 600th anniversary of the baptism of Lithuania (1987), the 1000th anniversary of the baptism of Rus' (1988) and other religious anniversaries to intensify anti-Soviet campaigns abroad, strengthen religious sentiments in the countries of the socialist community, and inspire extremist manifestations among believers.

in the area of combating the enemy's ideological sabotage actions on the channel of scientific, cultural, youth and sports exchanges

1. To identify and suppress attempts by enemy special services and foreign centers of ideological sabotage to use the expansion of contacts and exchanges in the fields of science, education and culture to intensify subversive penetration into various spheres of our socialist society.

2. Take coordinated measures to identify, prevent and suppress the enemy's intentions to use the platform of various international forums (scientific, cultural, youth, sports) to carry out subversive and other hostile actions aimed at discrediting the foreign and domestic policies of the countries of the socialist community and the ideology of Marxism-Leninism.

The delegations going to these forums should include agents and trusted persons capable of uncovering, preventing and resisting possible hostile actions by the enemy.

3. To exchange in a timely manner the information obtained about the enemy's plans to use international forums for hostile purposes and about specific persons of operational interest participating in them.

4. To uncover, document and carry out a mutual exchange of information on attempts by enemy intelligence services and foreign subversive centers to sow discord in the international youth movement, in particular in the International Union of Students (IUS) and the World Federation of Democratic Youth (WFDY).

5. Provide joint counterintelligence support for the activities of international organizations located in the Czechoslovak Socialist Republic (the International Organization of Journalists, the World Federation of Trade Unions, the International Union of Students, etc.), which are the target of the enemy's aspirations.

The agents and trusted persons working in these organizations are also to be used to develop foreigners suspected of having connections with the enemy's special services and subversive centers, in order to obtain political and intelligence information.

6. Conduct joint intelligence and operational activities to uncover and localize the enemy's ongoing attempts to inspire an anti-Soviet campaign in the West about the alleged use of psychiatry for political purposes in socialist countries.

7. Exchange work experience with foreign students and interns studying in our countries.

Inform each other about specific individuals of operational interest. Pay special attention to identifying and suppressing extremist manifestations among students and interns from Arab countries.

Organize joint development of objects from among foreign students and interns studying in our countries when they travel to the USSR or the Czechoslovak Socialist Republic.

8. 10 The Directorate of the KGB of the Czechoslovak Socialist Republic will inform the 5th Directorate of the KGB of the USSR about agents from among foreign students and trainees who, after completing their studies and returning to their homeland, will not be used by Czechoslovak intelligence. In the event of a decision being made on the advisability of using their operational capabilities in

According to the KGB of the USSR, these agents will be transferred to Soviet intelligence.

#### Conclusion

1. Contacts arising from the implementation of the tasks specified in this plan will be carried out in accordance with the Agreement on Cooperation between the KGB of the USSR and the Federal Ministry of Internal Affairs of the Czechoslovak Socialist Republic of 10 February 1972 and the plan of targeted meetings of both ministries, approved by the Chairman of the State Security Committee of the USSR and the Minister of Internal Affairs of the Czechoslovak Socialist Republic.

2. The exchange of information will be carried out through the international relations departments of both contracting parties and the Representative Office of the KGB of the USSR to the Federal Ministry of Internal Affairs of the Czechoslovak Socialist Republic in Prague.

3. Individual provisions of this Plan may, at the suggestion of one of the parties and by prior agreement of the relevant heads of departments and with the consent of the Chairman of the State Security Committee of the USSR and the Minister of Internal Affairs of the Czechoslovak Socialist Republic, be supplemented, replaced or excluded.

4. The activities specified in the Plan, for the implementation of which it is necessary to use the capabilities of other operational units of the KGB of the USSR and the Federal Ministry of Internal Affairs of the Czechoslovak Socialist Republic, or which concern objects that are simultaneously objects of other operational units, are carried out by the 5th Directorate of the KGB of the USSR and the 10th Directorate of the KGB of the Czechoslovak Socialist Republic together with the relevant units of the KGB of the USSR and the Federal Ministry of Internal Affairs of the Czechoslovak Socialist Republic.

5. An integral part of this Plan is the List of joint intelligence and operational activities on objects of mutual interest, which, by agreement of the heads of departments and in accordance with the needs of both parties, can be updated.

6. The plan shall enter into force on January 1, 1987, shall be valid until December 31, 1991 and shall be subject to approval by the Chairman of the State Security Committee of the USSR and the Minister of Internal Affairs of the Czechoslovak Socialist Republic.

joint intelligence and operational activities on objects of mutual operational interest of the 10th Directorate of the National Security Corps of the Czechoslovak Socialist Republic and the 5th Directorate of the State Security Committee of the USSR

1. In the development of radio stations "Freedom" (RS), use the capabilities of agents "Karel", "Grand" (KNB of the Czechoslovak Socialist Republic), "Fairy", "Baryshev" (KGB of the USSR).

2. Continue to carry out activities to introduce agent "Grand" (KNB of the Czechoslovak Socialist Republic) into the development of the employee of the "Russian Section" of the RS in Munich, David Allis, born in 1933, husband of the subject of the "Lioness" case, Alexandra Allis, born in 1934, a Czech by nationality.

For these purposes, use the friendly relations between the "Grand" and the "Lioness".

In the first quarter of 1987, the Grand was to be routed to Germany to meet with the objects.

Considering that the Allises maintain contact with the hostilely oriented Czechoslovak emigration, send an agent to identify possible channels for collecting information about socialist countries for the RS through sources in the emigration environment.

3. Prepare and implement measures to introduce agent "Karel" (KNB of the Czechoslovak Socialist Republic) into the development of the employee of the Ukrainian section of the RS, Gregory Panchuk.

For these purposes, in 1987, Karel was sent to the FRG to meet with Panchuk, having determined for him the appropriate line of conduct.

The agent will also have recommendations from Ukrainian nationalists, objects of development of the - 10th Directorate of the National Security Committee of the Czechoslovak Socialist Republic, and will inform Panchuk about his connections in Ukraine.

In this case, provide for the introduction of a KGB agent of the USSR into Panchuk's field of vision through "Karel".

4. In developing RFE, use the capabilities of the agents "Aramis" (KNB of the Czechoslovak Socialist Republic) and "Goya" (KGB of the USSR);

5. Continue the activities to set up RFE agent "Aramis" (KNB Czechoslovakia), with whom RFE emissary, the subject of the "Needle" case, SCHNEIDER Thomas, born in 1957, had previously established contact.

"Isla" instructed "Aramis" to collect information of interest to RFE "

Taking this into account, when planning and conducting activities on the case, provide for the possibility of the 10th Directorate of the KNB of the Czechoslovak Socialist Republic and the 5th Directorate of the KGB of the USSR preparing disinformation to convey it, if necessary, to RFE through agent "Aramis".

Upon the next visit of "Isla" to the Czechoslovak Socialist Republic or the USSR, operational measures should be carried out in relation to him that would exclude the decryption of "Aramis".

Provide for the creation of conditions for the withdrawal of the "Needle", if necessary, to the territory of the Czechoslovak Socialist Republic or the USSR with the aim of capturing it red-handed.

6. Prepare and implement joint counter-propaganda measures to expose the subversive activities of RS/RSE and their connections with the CIA. For these purposes, use information and documentary materials received from the former RS employee who returned to the USSR. Tumanov, as well as those available in the KNB of the Czechoslovak Socialist Republic and those newly received.

7. In the development of "Amnesty International" (AI), use the capabilities of agents "Radko", "Marko" (KNB of the Czechoslovak Socialist Republic), "Holger" (KGB of the USSR).

8. The development of the Milan branch of Amnesty International is carried out through the agent "Radko", who was set up as an employee of this branch, the subject of the "Svatava" case, Vignala Svatava, born in 1930, a Czech who emigrated from the country in 1948.

"Svatava" transmits the information received from the agent to the MA center in London. Use this fact to convey to the MA center in London through "Radko" and "Svatava" materials showing the futility of the subversive activities of "Amnesty International" against the countries of socialism.

Consider the possibility of preparing and implementing measures to set up a KGB agent of the USSR through "Radko" of "Amnesty International".

9. In developing the PEN Club, use the capabilities of agents "Anna" (KNB of the Czechoslovak Socialist Republic) and "Mikhailov" (KGB of the USSR).

10. In the "Strela-P" operation to set up agents of the KGB of the USSR and the KNB of the Czechoslovak Socialist Republic for the foreign center of the NTS, use the newly discovered capabilities of agents "Martin", "Milan", "Ivanov", "Ben", "Rada", "Stanek", "Boris", "Sasha", "Aristotle" (KGB of the Czechoslovak Socialist Republic), "Volkov", "Yeniseisky", "Novy", "Aleksandrov" (KGB of the USSR).

Each agent must determine a specific line of behavior, the implementation of which will contribute to the expansion of its capabilities in the development of NTS.

II. Continue to carry out joint activities to set up agents "Aleksandrov" and "Yakovlev" (KGB USSR) for the employees of the Austrian NTS center Pfandl and Roegl through agent "Aristotle" (KGB of the Czechoslovak Socialist Republic).

In particular, to create conditions that would encourage NTS to communicate with "Aleksandrov" and "Yakovlev" through employees of the Austrian embassy in Moscow.

In this case, consider the option of capturing an emissary or liaison of the NTS on the territory of one of our countries.

Take measures to create conditions for the joint withdrawal of KGB agents from the territory of the Czechoslovak Socialist Republic to foreign nationalist centers using so-called fictitious marriages.

12. In 1987, begin joint preparation of agent "Martin" (KNB of the Czechoslovak Socialist Republic) for long-term settlement abroad with the aim of infiltrating the NTS center.

"Martin" is actively used in the development of NTS, and the information received from it is of practical operational interest.

The agent repeatedly took NTS courses abroad, was hired as a freelance NTS employee and received an invitation to work at NTS as an official employee.

13. Continue activities to set up agent "Volkov" (KGE USSR) for the NTS center through agent "Rada" (KNB Czechoslovakia).

"Rada" informed NTS about "Volkov" and sent the article he had prepared to the Center.

Assuming a possible approach by the NTS emissary to "Rada" or "Volkov" and an expression of interest in the latter, organize in 1987 the routing of "Volkov" to the Czechoslovak Socialist Republic with the aim of strengthening his acquaintance with "Rada" and determining for him the appropriate lines of behavior.

When developing the next steps in the case, provide for the possibility of mutual decryption of agents, as well as the option of capturing the NTS emissary upon exiting to "Rada" or "Volkov", if such a need arises.

14. Determine for agent "Ben" (KNB of the Czechoslovak Socialist Republic), who is in correspondence with NTS employee Artemov and who is receiving NTS materials from abroad, a line of behavior that would stimulate NTS to establish a personal connection with him.

Find a way to route "Ben" abroad to meet with Artemov.

15. Route agent "Sokol" (KNB of the Czechoslovak Socialist Republic) abroad, where he has stable connections with hostile representatives of the Orthodox Church in France and the FRG and has the ability to identify possible channels of their communication on the territory of the Czechoslovak Socialist Republic, the Polish People's Republic and the USSR.

Through agent Sokol, organize a check of the signal about the connection of the Polish priests Matrenchik and Sdaykovsky with the NTS and the International Literary Association, as well as about their subsequent use for the transfer of hostile materials to the USSR.

16. Complete the activities to set up the NTS center in France with agent "Novy" (KGB of the USSR) through agent "Milan" (KGB of the Czechoslovak Socialist Republic).

In 1987, Milan was sent to France to meet with NTS employees and convey targeted information about the New.

17. Complete preparations and implement counter-propaganda measures to expose the hostile activities of the NTS. For this purpose, use in the media materials received from agent "Ataman" (KNB of the Czechoslovak Socialist Republic), who previously worked in the NTS center.

18. Continue to conduct joint activities to identify emissaries and liaisons of the OUN in the "Trassa" case.

In events, use agents "Taras", "Gelena", "Judita", "Inter", "Karel" (KNB Czechoslovakia), "Vasiliev", "Richko", "Javornitsky", "Maxim", "Nalivaiko", "Vera", "Beskid" (KGB of the USSR).

Interact in the development of the identified OUN emissaries Kravchenko, Khimko, Veriga, Kisolik, Khomyak, Senkus, Palme and others.

Take coordinated measures to create conditions for capturing the OUN emissary red-handed during his next visit to the Czechoslovak Socialist Republic or the USSR.

19. Complete verification activities regarding agent "Philip" (KNB, Czechoslovakia). In the event of receiving information about "Philip" maintaining conspiratorial ties with the foreign center of the OUN, take him into active development.

Continue using "Philip" to set up the OUN center for agent "Vasiliev" (KGB USSR).

For these purposes, in the first half of 1987, route "Vasiliev" to the Czechoslovak Socialist Republic. Create conditions for the OUN emissary to reach "Vasiliev" during this period.

20. In developing the case of the "Enemy" (KNB of the Czechoslovak Socialist Republic), who transferred the so-called "memoirs" to the OUN center in Munich, use agents "Kitty", "Lastovka", "Vaclav", "Karel" (KNB of the Czechoslovak Socialist Republic), "Maxim", "Nalivaiko" (KGB of the USSR).

Through agent "Nalivaiko", organize the departure of the "Enemy" to the USSR, where they will conduct intelligence-operational verification activities against him.

Introduce agent "Tulsky" (KGB SSS living in Karlovy Vary, whom the target considers his spiritual leader) into the development of the "Enemy".

"Tulsky" should be oriented towards studying the personality of the "Enemy", identifying his connections with foreign subversive centers, and systematically implementing preventive measures against the target.

21. Develop and implement measures to restore communications between agent "Taras" (KNB of the Czechoslovak Socialist Republic) and the foreign center of the OUN with the aim of conveying to the OUN information about his associate in Ukraine, agent "Richko" (KGB of the USSR), and the existence of a reliable communication channel between "Taras" and "Richko" through "Igor" (KNB of the Czechoslovak Socialist Republic) and "Antey" (KGB of the USSR).

22. Continue measures to strengthen the contact of agent "Judita" (KNB of the Czechoslovak Socialist Republic) with connections in the USA involved in the activities of the OUN against the USSR, and to set them up through "Judita" as an agent of the KGB of the USSR.

23. To intensify the development of the Ukrainian nationalist, the subject of the "Danko" case (KNB of the Czechoslovak Socialist Republic) Neverli Mikulas, born in 1916, in the direction of identifying and operationally advantageous use of the communication channel he has with the OUN through the employee of the Italian embassy in Prague SANTE Cavin

---

For these purposes, use agent "Litera" (KNB of the Czechoslovak Socialist Republic) and route agent "Vera" (KGB of the USSR) to the Czechoslovak Socialist Republic, having determined for them the appropriate lines of conduct.

24. In the development of Ukrainian nationalists, the subjects of the "Garfa" case - Olga Dutko, born in 1910, and Ivan Dolina, born in 1911, who allegedly have channels of communication with the foreign center of the OUN, use the capabilities of agents "Beskyd", "Yavornitsky" (KGB USSR), for which purpose they are routed in 1987 to the Czechoslovak Socialist Republic.

25. Complete the preparation of a joint active counter-propaganda event to expose to the world community the reactionary essence of Ukrainian bourgeois nationalism and the connections of the OUN with the special services of Nazi Germany.

For these purposes, based on selected archival and other materials, publish documentary brochures in mass circulation and distribute them through existing opportunities abroad. Use the "Repo" agent (KNB of the Czechoslovak Socialist Republic) in preparing the brochures.

26. Through the capabilities of the agents "Mirek", "Professor", "Trdlička" (KGB of the Czechoslovak Socialist Republic), "Svetov" (KGB of the USSR) control and give direction to the preparation of the World Ecumenical Conference "Justice, Peace and Integration of Creation", which the World Council of Churches is preparing to convene in 1990. With the help of agents of influence, ensure that the Christian Peace Conference is involved in the preparation of the conference, capable of orienting it in a progressive spirit and rebuffing anti-communist and anti-socialist manifestations.

27. To jointly monitor and provide direction for the preparation of the UP of the General Assembly of the World Council of Churches, which will be convened in 1991. To pay attention first of all to the further consolidation and staffing of the organs and committees of the World Council of Churches by means of candidates from the countries of the socialist community and from non-aligned countries.

28. Continue joint development of the General Secretary of the WCC Emilio Castro. Through the existing intelligence and other capabilities of "Estrzhab", "Professor", "Milan" (KGB of the Czechoslovak Socialist Republic), "Ostrovsky", "Sveto Nesterov" (KGB of the USSR) and others, collect information characterizing him and his relatives, identify his connections in political, religious circles, international organizations, influence him in a way that is beneficial to

29. Through the operational capabilities of agents "Zhaneta", "Ondrej", "John", "Mirek" (KGB of the Czechoslovak Socialist Republic), "Drozdov", "Remarque", "Mikhailov" (KGB of the USSR) and others, take measures to promote persons with an orientation favorable to us to the posts of chairman and vice-chairman of the presidium of the Conference of European Churches (CEC), to strengthen the peacekeeping focus of this organization and to ensure the implementation of positive decisions adopted at the 9th General Assembly.

30. To expose the plans of the foreign Uniate Church to penetrate into the Czechoslovak Socialist Republic and the USSR, use the capabilities of the agents "Ondre Chestny" (KGB of the Czechoslovak Socialist Republic), "Varuzhan", "Kaplunov", "Neptune" (KGB of the USSR)

For the same purposes, agents "Ondrej", "Honest" are sent to Canada and the USA for training through the Uniates, and agents "Potochina", "Orthodox", "Winter" (KGB of the USSR) in the Czechoslovak Socialist Republic, who have connections among people close to the Uniate Church.

### 31. Carry out joint counterintelligence activities aimed at:

- Providing worthy celebrations on the occasion of the 30th anniversary of the establishment of the Kharkiv Metallurgical Plant (1988).
- Ensuring the preparation and progress of the meeting of the Committee for the Continuation of the Work of the KMK in the autumn of 1988 in Görlitz (GDR).
- Provision of personnel and ideas for the preparation of the UP-th All-Christian Peace Congress, which will take place in 1992 in Prague.
- Ensuring preparation for the so-called Budapest Peace Theological Seminar "Towards a Theology of Peace", which will take place in January 1987 in Prague, and the so-called Budapest Peace Conference, in October 1987 in Budapest.
- Providing support for the 10th Plenum of the Berlin Conference on the territory of the GDR, 1987.

32. Organize joint development of the subject of the "Violet" case - Franke ELEISCHHAMMER, born in 1957, Hamburg, employee of the KMK, suspected of having ties to the special services of the FRG.

In the study of "Violet", use agents "Lada", "Mirek", "Rogach" (KNB of the Czechoslovak Socialist Republic), "Prokhorov" (KGB of the USSR).

33. Organize joint development of the object of the case "Fish" of the employee - of the scientific department of the HMC Steven Fisher (US citizen), suspected of belonging to the US special services. In his study, use agents "Hrdlichka", "Mirek", "Lada" (KNB of the Czechoslovak Socialist Republic), "Pro-- Khorov" (KGB of the USSR).

34. Agent "Misha" (KGB USSR), studying at the Jan Hus Theological Faculty in Prague, is to be used to study the situation in this educational institution and to identify negative manifestations among students. Also orient him toward identifying facts of the introduction of Catholicism and Pentecostal ideas into the student environment.

35. To send agents to foreign subversive centers, use the "Summer Courses in Slavic Languages" at Charles University, where people from the USA, England, France, Canada and other capitalist countries are studying.

For these purposes, the 10th Directorate of the KGB of the Czechoslovak Socialist Republic will direct its efforts to acquiring agents from among the teachers and students of these courses. The 5th Directorate of the KGB of the USSR will select 2-3 agents to send to them.

36. In the development of the subject of the "Sava" case (Ivan Havel, chartist), his connection with Vasily Vasilyevich Nalimov (research associate at the laboratory of statistical methods at Moscow State University) was revealed. Study the possibility of operational use of Nalimov in the "Sava" case.

37. The development of foreign Zionist organizations (WJC, WZO, etc.) and their emissaries is to be carried out through agents "Jan", "Editor", "Arthur", "Cadillac", "Slavek", "Prohazka" (KGB of the Czechoslovak Socialist Republic), "Vostokov", "Lensky", "Zav'yalov" (KGB of the USSR).

38. Carry out joint activities to expose the hostile activities of Zionist emissaries and Jewish nationalists visiting the Czechoslovak international resorts in Karlovy Vary and Pestany.

For these purposes, the 5th Directorate of the KGB of the USSR will send trusted agents to these resorts for the summer period. The 10th Directorate of the KGB of the Czechoslovak Socialist Republic will determine the circle of foreigners of Jewish origin who have repeatedly visited the resorts and on whom operational materials have been obtained. In the event of another visit to the country, agents from among the health care personnel and agents "Arthur", "Cadillac", "Slavek" working in the fight against subversive activities of foreign Zionists will be used in their development.

Control over the allocated development objects will also be carried out using operational and technical means.

To coordinate activities with the 10th Directorate of the KGB of the Czechoslovak Socialist Republic and work with agents in the Czechoslovak Socialist Republic, an operative from the 5th Directorate of the KGB of the USSR will be sent during this period.

39. Carry out joint counter-propaganda activities to expose the reactionary nature of international Zionism and their hostile plans to penetrate socialist countries.

The Czechoslovak side will use the experience of the Anti-Zionist Committee of the Soviet Public and create conditions for the translation and publication of materials with anti-Zionist themes in the Czechoslovak Socialist Republic and abroad.

40. Interact in conducting intelligence and operational activities to provide counterintelligence support for the following major international forums:

- International music festival "Prague Spring" (held annually in May in Prague). In the events use the capabilities of agents "Gorak", "Vilem", "Leviky", "Evan", "Burian", "Otakar" (KNB of the Czechoslovak Socialist Republic).
- International Book Fair in Moscow (held every 2 years) (agent "Pavel", trusted person "Itka" (KNB of the Czechoslovak Socialist Republic), "Volodin", "Petrov", "Vladimirov", "Tonin" (KGB of the USSR).
- International Book Fair in Frankfurt am Main (held annually in October) (trusted persons: "Itka", "Jan" (KNB of the Czechoslovak Socialist Republic; "Alexey", "Arkadyev", "Zagoruiko" (KGB of the USSR).
- International Philosophical Congress in Delhi, India, 1987 (agent "Organizer" (KNB of the Czechoslovak Socialist Republic).
- World Congress of the Movement of Physicians to Avert Nuclear War (MPANW) in Moscow, September 1987. Trustees: "Vedets", "Expert" (KNB of the Czechoslovak Socialist Republic). The IO Directorate of the KNB of the Czechoslovak Socialist Republic is sending an operative to Moscow to provide counterintelligence support for the congress.
- European Conference of the IPINV Prague, November 1987. Trustees: "Vedets", "Expert" (KNB of the Czechoslovak Socialist Republic).
- World Congress of Political Scientists, Rio de Janeiro, Brazil, 1989. Agent: "Pravnik", trusted persons "Blagozh", "Matoush" (KNB of the Czechoslovak Socialist Republic).
